House Regulations / Terms of Use

1.1 Every visitor on the premises of the Greifsbloc e.V. climbing gym agrees to fully comply to the latest terms of use, and furthermore takes responsibility for the actions of those under his legal guardianship.

- 1.2. Usage of the climbing wall at ones own risk and liability.
 - 1.3. Every visitor has to contact the staff upon arrival.
- 1.4. Every visitor must comply with the instructions and orders of the staff.
 - 1.5. The sound system is not to be used outside official business hours.

1.6. The behavior on the premises is one of mutual respect, tolerance and peacefulness. The personnel may expel individuals attracting attention through racist, sexist, homophobic and other discriminating behavior.

1.7. Everybody on the premises agrees to the Greifsbloc e.V. that photos of themselves may be used for advertising purposes.

2. Climbing hall and climbing wall

- 2.1. The area in which people who are currently climbing the wall might fall is to be avoided. Individual sections of the wall are only to be used by one person at a time.
- 2.2. Jumping off the wall onto the mattress has to be done in a controlled manner and with consideration to others.
 - 2.4. The upper red border is not to be exceeded.
 - 2.5. Climbing is only allowed in the areas with mattresses beneath.
- 2.6. Every user of the climbing wall must be aware that grips might turn or in extreme situations even break. Therefore, users are liable for possible injuries. We do not guarantee the strength or firmness of the grips. Loose structures, grips and other deficiencies have to be reported to the personnel.
 - 2.7. Unauthorized changes, i.e. changing the position of grips and other manipulations regarding the premises and property of the Greifsbloc e.V. are strictly prohibited.
 - 2.8. Climbing under the influence of alcohol, narcotics, drugs and/or similar substances is

strictly prohibited.

3. Children

3.1. Children up to the age of 14 are allowed to use the facilities of the premises under the supervision of a legal guardian or an adult with a written mandate. Above the age of 14 a mandate of a legal guardian will suffice.

3.2. Adolescents of the age of 14 or older are allowed to use the facilities without parents/legal guardians, after presenting an appropriate written permit signed by the legal guardian.

3.3. Legal guardians and adults with supervising authority are liable for the children and persons entrusted in their care.

3.4. Playing inside the designated bouldering area and areas where objects or humans might fall is forbidden. Raving and running about is also not allowed.

4. Order and Cleanliness

- 4.1. Persons causing damage to the poperty or persons are held liable for these.
- 4.2. The climbing hall is to be kept clean. Consumation of foods or drinks is not allowed on the mattresses. Leftovers are not to be left inside the hall.
- 4.3. Magnesium and chalk is only allowed as magnesia-balls or liquid chalk. The usage of open or loose chalk is forbidden.
 - 4.4. Smoking inside the building is strictly prohibited.
 - 4.5. Bicycles are not to be parked inside the hall.
 - 4.6. Information and warning signs are to be observed and respected.

5. Liability

- 5.1. Persons entering the premises and using the facilities in the hall do so on their own responsibility.
- 5.2. The association and the staff on duty assume no responsibility for transgressions.
 - 5.3. We as an association take no liability for personal belongings.

5.4. Aside from the statutory liability provisions, the user is training on their own responsibility and liability. This especially concerns claims resulting from transgressions of the terms of use.

5.5 Theft is to be reported immediately.

6. Domiciliary right

Violations of the house regulationsmay result in a ban on entering the premises for an indefinite amount of time.

7. Severability clause

Should any part of this agreement be found is found to be invalid or unenforceable, only that particular provision or part so found, and not the entire Agreement, will be inoperative.
